ENTRIES: In order to participate, all dogs must be 18 months of age or older. Bitches in season, or any dog suffering from a deformity, injury or illness which may affect the dog's physical or mental performance are not eligible to participate.

REFUNDS: Refunds will only be issued for bitches in season or in the case of an injury/illness to the dog. (Veterinarian note must be provided in both cases.) Any other refund requests will be treated case by case at the trial chair's discretion.

OBSTACLE FAMILARIZATION: Will not be permitted. Warm up jumps will be provided for dogs who are about to run.

PLEASE NOTE: Food, toys, or any other training devices will not be permitted in the ring. Please pick up after your dog and do not litter. Unacceptable behavior including disruption during the trial, poor sportsmanship, or any kind of abuse towards your dog, volunteers, competitors, or the judge will not be tolerated.

 PARTICIPATION WAIVER AND RELEASE**

In consideration of the acceptance of this entry by AAC and Riverside Agility (the "Organizing Club") and the opportunity to have the Dog participate,

compete in and/or be judged at this event or trial (the "Event"), I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my "Related Parties"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the "Personnel") for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. Listing Fees are payable with the entry for dogs that do not have their individual CKC Registration Number, or CKC Event Registration Number (ERN) **Official CKC Entry Forms MUST be used.**

No post dated cheques will be accepted. A post dated cheque is one that is dated after the receipt of the entry. **All N.S.F. cheques will be subject to a charge of \$20.00.** N.S.F. cheques are considered non-payment of entry fee and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the show.

Attention USA Exhibitors: Please note that due to constantly fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, **however**, they are to be payable in Canadian Funds. If you send a cheque in US Funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not make cheques “Payable In Canadian Funds” or “At Par”, they will NOT be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You!

NON-MEMBER PARTICIPATION FEE

A non-member participation fee will be charged to a resident of Canada who is a “non member” of the Canadian Kennel Club. The non member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. The fee applies only to dogs wholly owned by non member residents of Canada and is not applicable to Canadian Kennel Club members

REFUND INFORMATION

Entry Fees **will be refunded for bitches that come into season after the closing date. Entry fees will also be refunded for dogs/bitches that pose a threat of communicable diseases on the day of the trial. To obtain either of these refunds a letter from a Veterinarian must be presented to the Trial Secretary prior to the commencement of the trial.**

ELIGIBILITY

In order to be eligible to compete in these Trials, a dog must be registered with the CKC and have a CKC Registration Number, an ERN, PEN, CCN or Misc Certification Number, or be eligible for the same. Dogs may be spayed or neutered and/or debarked. Dogs must be 18 months of age or older. Dogs may not be lame. These Agility Trials will be held outdoors at the Irishtown Community Centre Ball Field Irishtown New Brunswick. The surface is grass. The precincts of these trials will be the ring and 10 feet surrounding it.
