In consideration of the acceptance of this entry, the holding of this event and the opportunity to have the dog participate or be judged, I (we) agree to hold the organizing committee, the organization which it represents, including its members, officers and directors, owners of premises upon which the event is held and their employees, harmless from any claim for loss of injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence or any other person, or any other cause or causes.
